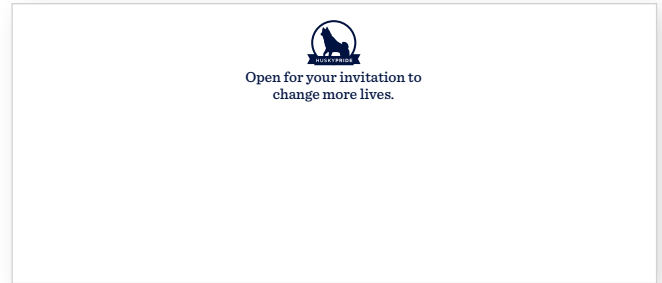


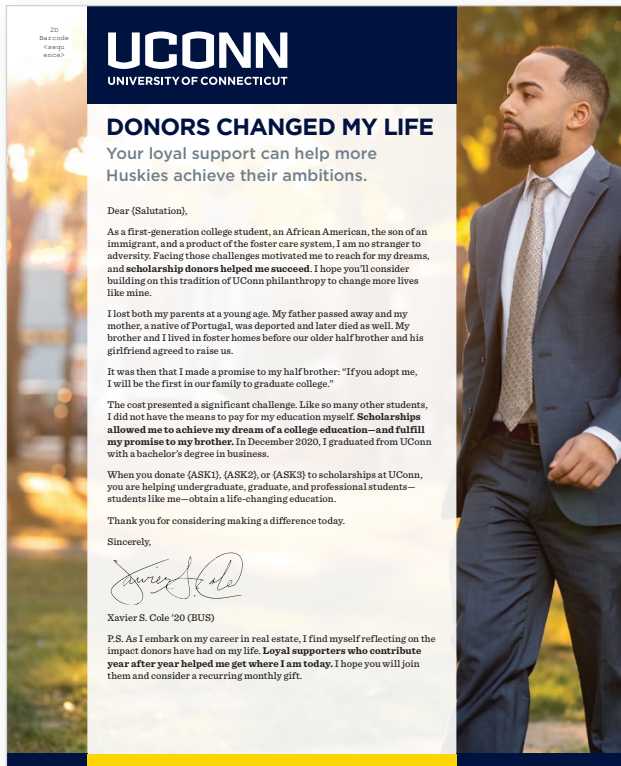

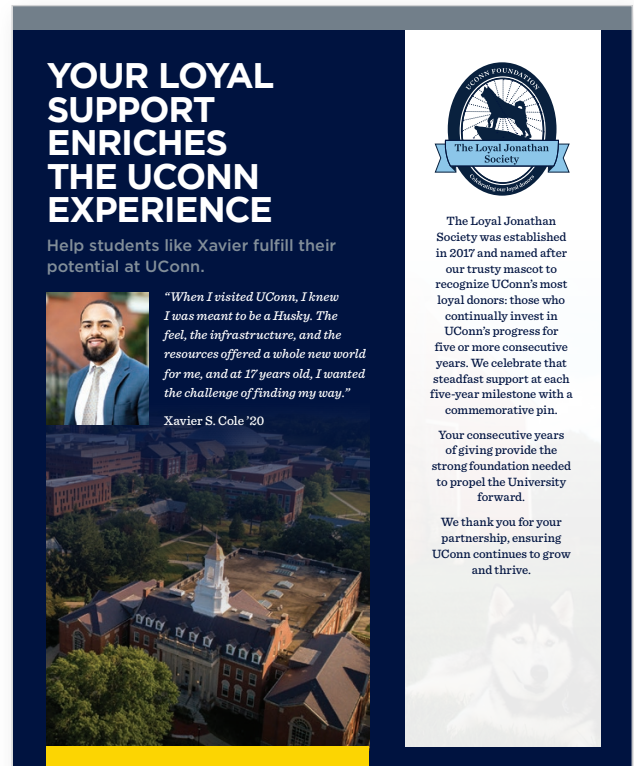

As a first-generation college student, an African American, the son of an immigrant, and a product of the foster care system, I am no stranger to adversity. Facing those challenges motivated me to reach for my dreams, and **scholarship donors helped me succeed**. I lost both my parents at a young age. My father passed away and my mother, a native of Portugal, was deported and later died as well. My brother and I lived in foster homes before our older half brother and his girlfriend agreed to raise us.

It was then that I made a promise to my half brother: "If you adopt me, I will be the first in our family to graduate college."

The cost presented a significant challenge. Like so many other students, I did not have the means to pay for my education myself. **Scholarships allowed me to achieve my dream of a college education—and fulfill my promise to my brother**. In December 2020, I graduated from UConn with a bachelor's degree in business.
